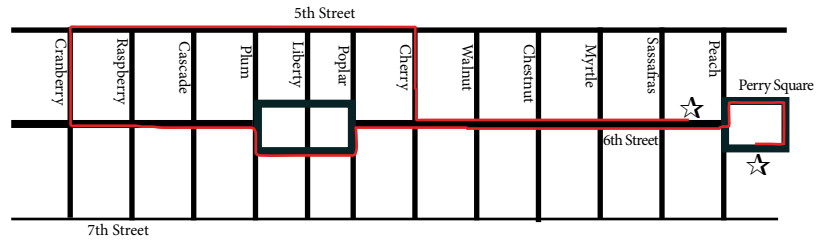
# 15th Annual Law Day 5K Run/Walk
