1. Why are you seeking the position of Judge of the Court of Common Pleas?

The courtroom should be a place where people of all economic and social statuses have the opportunity to seek justice. At minimum it is a place where those who feel they don't have a voice can finally be heard whether firsthand or through legal representation. I have a strong belief in the court system as well as protecting the rights of all individuals. When the right person is elected to this position we are doing our entire community and legal system a justice in itself.

I have focused my career on helping people navigate the court system while finding a level of comfort and security in the system. I am seeking this position to further my career in public service and continue to have an impact on the safety, equality, and well-being of the citizens of Erie County.

Explain how your practice has prepared you for the position of Judge of the Court of Common Pleas.

I have served as a prosecutor in the District Attorney's Office for over 16 years, having practiced every aspect of Criminal Law. I have prosecuted thousands of cases with a specialization in domestic violence and sexual assault. To date I have prosecuted 26 murder cases, 18 of those cases have been jury trials.

My career has provided me with so many opportunities to give support as well as a sense of closure and justice. It is a rewarding position and I have many significant achievements. Along with my homicide prosecutions, I have helped sexual assault victim's find their voice in the courtroom. I created a policy to streamline violations of Protection from Abuse Orders through the system; simplifying the process for victims and police officers.

In 2014 I came across a violent rape case that was over 15 years old. Upon learning the defendant had fled and therefore was never prosecuted for his actions, I pulled the file and began doing research on the case. I learned the victim was deceased and felt strongly that despite her death she deserved justice. After research, briefs, and arguments I was able to get the case before a jury and fight successfully for a

conviction.

My job as a prosecutor has prepared me for the position of Judge in many ways. I have spent almost every day in the courtroom, working with people from various backgrounds. I have experience with courtroom procedure, evidence, researching and writing appeals. I make decisions that impact the safety and security of businesses and individuals of Erie County while taking into account the needs of the defendant. My job requires me to look at the bigger picture and the best interest for all parties
