1. Why are you seeking the position of Judge of the Court of Common Pleas?

For 29 years I have been a trial lawyer. I have dedicated my career to the study and practice of law, and have decided to seek the position of Judge of the Court of Common Pleas so I can put the skills I have honed to use in a different capacity, serving the people of Erie County, in the place that has always been my passion – the courtroom. I believe I possess the required temperament, demeanor, diligence, and professionalism to do the job well.

2. Being careful to maintain client confidentiality as embodied in the Rule 1.6 of the Rules of Professional Conduct, describe the general character of your law practice, including areas of concentration and the most significant achievements of your legal career. Explain how your practice has prepared you for the position of Judge of the Court of Common Pleas.

As an attorney in private practice at a full-service law firm for my entire career, I have had the opportunity to work in many areas of the law for my clients, and the clients of the Quinn Law Firm. My experience includes the practice areas of civil and criminal law, residential and commercial real estate, assessment appeals, wills and estates, private foundations, wrongful death cases, departmental hearings with the State Boards of Professional Licensing, hearings with the Department of Transportation, Office of Children and Youth hearings, Protection from Abuse Hearings for both plaintiffs and defendants, child dependency proceedings, and juvenile criminal cases and trials. The focus of my trial work is handling criminal cases, and I have conducted jury trials in Erie County, Crawford County, Warren County, and Cumberland County. I have handled criminal and civil cases in 18 different counties in Pennsylvania.

One of my most significant achievements is having my colleagues and Judges who were surveyed award me a Martindale-Hubble AV rating, which I have held since 2011. For attorneys and Judges

to give me that rating is something I am very proud to have achieved. The diversity of my legal experience has given me a well-rounded background to serve on the bench as a Judge of the Court of Common Pleas.

I appear in court regularly - on average 175 to 225 times per year. I also handle cases in federal court in the Western District of Pennsylvania.

I have tried more than 50 cases to verdict or decision in my career as either sole counsel or chief counsel, with the criminal trial practice involving homicide, felonies, misdemeanors, and juvenile trials.

I have represented clients at administrative hearings in Erie County, Warren County, Crawford County, and in Harrisburg. These hearings range from the Governor's Board of Pardons, professional licensing issues, permits, gaming – State Board of Nursing, Dentistry, Pharmacy, Physical Therapy; Office of Children and Youth – estimated at 15% of practice time.

5. Do you have experience with ADR? If so, give details.

Yes – my clients in need of legal services in practice areas applicable to ADR are encouraged to utilize the process and utilize mediation if the facts of their situation warrant the choice. I have utilized it for two clients in Federal Court. I have also referred numerous clients to the Quinn Family Law Department, and to attorneys outside of Quinn that utilize ADR. Throughout my career I have participated as an Erie County Arbitrator.

6. Which judges or justices do you most admire and why?

I draw upon my 29 years of experience and the number of times I have appeared in Court to specifically answer this question. I have represented clients before many Judges of the Court of Common Pleas, Magisterial District Judges of the Minor Judiciary, and Judges in Federal Court. The judicial qualities I admire most involve treating the parties and counsel with respect and dignity. Judicial temperament combined with the ability to hear the issues and listen to the evidence and arguments of the attorneys are extremely important. I appreciate Judges that allow the attorneys to present their cases they have prepared so thoroughly for, without undue interreference from the Bench. I admire Judges that are fair and decide wisely, especially those Judges that are diligent in explaining to the parties why a certain decision was reached.

8. Describe your involvement in community activities.

I am a volunteer board member for the Paul Kostkan Foundation that benefits charitable and civic organizations in Western Erie County.

Since 1993, I have volunteered as a coach at nearly every level for youth sports involving grades

K through 12. Since 1998, I have volunteered as the Attorney Advisor to the Northwestern High School Mock Trial Team (1998-2014, 2021-present), Albion Springfield Little League Baseball Coach (2011-2019), Northwestern Youth Basketball Coach (2014-2017), Northwest Little Gridders Football Association Coach (2017-2021), Northwestern High School Varsity Football Coach (1993-2007, 2018-present), Northwestern Middle School Football Coach (2018-present), Northwestern Middle School Basketball Coach (2018-2022), and the YMCA.

9. What do you consider a significant achievement in your life outside your profession? Describe it.

I have been married to my wife Becky for 17 years, and I am very grateful for and proud of the family we are raising together. We have four children, Cole, Brodie, Mason, and the mighty Tess (Tessa). They all attend school (grades 11, 9, 7, and 6, respectively) in the Northwestern School District in Albion, Pennsylvania. They each have their unique strengths and personalities. They exhibit high moral character, and they all pursue life and its various activities to the fullest. 11. Describe your involvement in Erie County Bar Association activities.

In 1998, I started the Northwestern High School Mock Trial Team with teacher Greg Lehman and District Justice Robert Saxton. The ECBA had not previously had a Northwestern team in the competition. I volunteered as the Attorney Advisor, and Northwestern has continuously participated for 25 years in the statewide competition hosted by the ECBA. For the few brief years I was not the full-time attorney advisor (when our family grew to four children), I would volunteer as a jury member and even served as the Mock Trial Judge. Northwestern has had over 325 students participate in mock trial since 1998. Some of these students went on to legal careers as attorneys, paralegals, or worked closely with the legal profession.

I have presented seminars through the ECBA to attorneys and the young attorneys in their Legal 101 seminar series, and I attended the ECBA Bench and Bar Conference in New York in 2018. I am a 29 year active participating attorney in the ECBA, LRIS Program. I am a past Co-Chair of the Criminal Practice Committee. I have participated in the ECBA year-end meetings, golf outings, and holiday gatherings. I am also pretty sure we were undefeated softball champs as young lawyers of the famous Young Lawyers vs. Senior Sluggers, Judgement Day Softball Games held at what was then, Jerry Uht Park. Those games benefitted the local food pantry. Maybe we lost one game, ever!

12. How do you view the current relationship between the Bench and the Bar of Erie County? Do you think it can be improved? What would you do to maintain or improve relations between the Bench and the Bar if elected to the position of Judge of the Court of Common Pleas?

The current relationship between the Bench and the Bar is very positive and there exists a culture of cooperation. Those currently serving on the Bench are engaged and make themselves available to counsel to work toward case resolution when possible. The Bench and Bar have handled the challenges of the pandemic to the best of our collective abilities, and as we return to full-time court

activities, I believe we have worked together efficiently and effectively. If elected, I would continue to promote open dialogue between the Bench and the Bar so the cooperation can continue to make a better overall court system, ultimately benefitting the residents if Erie County.

13. Do you believe it is important for a Judge to remain involved in Erie County Bar Association activities? Please explain:

Yes. Judges that remain involved in Erie County Bar Association activities stay connected to the ECBA membership. I believe that connection helps keep a Judge grounded and reminded of the challenges of the practice of law in both public service and private practice. Being in touch with the members of the ECBA furthers the professionalism and respect the Bench and Bar have for one another, and it allows ongoing dialogue to bring change when needed to improve our service to Erie County.

14. What do you envision to be your continuing role with the Erie County Bar Association should you be elected? Would you attend substantive and social gatherings of that Bar Association?

If elected, I would be an active member in the Erie County Bar Association, attending committee meetings that did not conflict with my responsibilities of being a Judge. I would attend substantive activities and social events to keep connected with the local legal community, and I would make myself available to hear ideas on how to improve our legal system and courthouse procedures. I would stay actively involved in the ECBA sponsored Mock Trial Program to ensure high school students have the opportunity to participate in what is for many, a life changing experience.
