Appointed Judge of the Erie County Court of Common Pleas by Governor Tom Wolf and unanimously confirmed by the Pennsylvania Senate on May 7, 2019, I have served in the court's Family Division since June 28, 2019. In just over 19 months on the bench, I have now presided over cases involving all areas of the law, including criminal, civil, family, dependency, and delinquency cases.

I bring to the bench my experience as a lawyer for 30+ years. Prior to becoming a Court of Common Pleas judge, I had 28 years of courtroom litigation experience. I engaged in courtroom litigation since my early days as a U.S. Army Trial Counsel and Special Assistant U.S. Attorney in Ft. Riley, Kansas, through my 5½ years as an Assistant and Deputy District Attorney in Erie County, and to my 20 years of experience as the chief federal prosecutor in the U.S. Attorney's Office Erie.

My many years of courtroom litigation experience has prepared me to effectively deal with courtroom disputes and objections that arise in litigation. I have a keen understanding of how to properly manage caseloads and deadlines, deal with immediate evidentiary issues and objections that arise in court proceedings, manage complex legal problems, manage the style and temperament of opposing counsel, and be decisive when decisions must be made. I hope I have proven over the past 19 months that I possess the right temperament, experience, wisdom, reasonableness, sense of fairness, skill, and work ethic necessary to continue to serve Erie County as a Judge.
