**EIGHTH AMENDED JUDICIAL ORDER**

**AND NOW**, to-wit, this 30<sup>th</sup> day of March, 2021, **IT IS HEREBY ORDERED, ADJUDGED and DECREED** that, consistent with the Agency Order issued by the Centers for Disease Control and Prevention (“CDC”) entitled “Temporary Halt in Residential Evictions To Prevent the Further Spread of COVID-19,” 85 Fed. Reg. 55292 (September 4, 2020)<sup>1</sup>, Section 502 of the Consolidated Appropriations Act, 2021 (extending said Agency Order through January 31, 2021), the Agency Order issued by the CDC on January 29, 2021 (extending the eviction moratorium through March 31, 2021), and the most recent Agency Order issued by the CDC on March 29, 2021 (extending the eviction moratorium through June 30, 2021),<sup>2</sup> this Court’s “Fifth Amended Judicial Order” dated November 12, 2020, is **AMENDED** as follows:

All references to “December 31, 2020,” shall now read “**June 30, 2021.**”

**IN ALL OTHER RESPECTS, THE TERMS OF THIS COURT’S PRIOR JUDICIAL ORDERS SHALL REMAIN IN FULL FORCE AND EFFECT.**
