I am seeking this position to continue a career of public service in the courtroom.

Explain how your practice has prepared you for the position of Judge of the Court of Common Pleas.

My practice has been in the area of Criminal Law as an Assistant District Attorney for the past 11 ½ years. I have been involved in every aspect of the Criminal Justice system from investigations to prosecuting cases. I am knowledgeable in all areas of criminal law but specialize in the areas of domestic violence and sexual assault.

While it is difficult to determine which achievements throughout my career are the most significant, I will detail the moments that particularly stand out:

- Providing a sense of closure and justice to families who have lost loved ones to a violent crime
- Creating a policy streamlining the process for a plaintiff to file criminal charges for violations of their Protection from Abuse orders; simplifying the process for the victims while saving police officers time
- Preparing, researching and successfully renewing the prosecution of a 15 year old violent rape case where the defendant was a fugitive and the victim was deceased

My job as a Prosecutor has prepared me for the position of Judge in many ways. It has provided me with the opportunity to spend the majority of my time in the courtroom. I have observed and participated in all aspects of criminal law and in doing so I have gained invaluable courtroom experience. I know how the courtroom operates, how and when to use discretion, when to be to tough, and when justice requires compassion. Additionally, I have worked with a diverse group of individuals from various backgrounds.
