**William McKendree** is director of the Pennsylvania Healthcare Benefit Solutions program, a 501(c)(3) non-profit agency helping people access affordable healthcare services through counseling, education and advocacy.

Prior to his work at PHBSP, Mr. McKendree was program manager for the Allegheny County APPRISE office — Pennsylvania's Health Insurance Assistance Program. During his 13 years at APPRISE, more than 20,000 residents of Allegheny County were helped each year as they navigated through the complexities of state and federal healthcare benefit programs.

And before running Allegheny County APPRISE, he was director of the Western Pennsylvania Center for Aging Services, helping Pennsylvania's seniors access medical, legal and social services.

In addition to his work at PHBSP, Mr. McKendree teaches at the University of Pittsburgh's School of Pharmacy, and is preceptor for the School of Pharmacy's Experiential Learning Program at the Birmingham Free Health Clinic (on Pittsburgh's South Side). He also regularly teaches classes on health law and health care policy at Penn State University, La Roche University and Community College of Allegheny County.

Colin Morgan is a Certified Elder Law Attorney (CELA), the certification specialty awarded by the National Elder Law Foundation (NELF) as authorized by the Supreme Court of Pennsylvania. He assists clients in all phases of the long term care planning process. This includes Medicaid eligibility, Veterans benefits planning and traditional estate planning, all with an emphasis on issues specific to aging clients as well as younger clients with disabilities. In addition, Atty. Morgan assists families planning for children with special needs, including transitioning to adulthood as well as planning for litigation proceeds of injury victims who need to maintain important government benefits such as SSI and Medicaid. He is a frequent speaker on various Elder Law topics for the Community College of Allegheny County, and for health care professional education seminars and for community groups.

Defendants waiting too long for public defenders are entitled to dismissal of charges, suit says - Eight Wisconsin plaintiffs who have waited weeks or even months for appointed lawyers have filed a class action lawsuit claiming a violation of their right to counsel under the federal and state constitutions. The suit was filed Aug. 23 in Brown County, Wisconsin, against Democratic Gov. Anthony Evers, Wisconsin State Public Defender Kelli Thompson and other state officials. The suit alleges violations of the Sixth and 14th Amendments and a Wisconsin constitutional provision guaranteeing criminal defendants "the right to be heard by himself and counsel." One of the plaintiffs has been waiting for an appointed lawyer for nearly a year while in the La Crosse County Jail. University that scanned student's room during remote test violated Fourth Amendment, judge rules - Cleveland State University violated the Fourth Amendment when its proctor ordered a scan of a student's bedroom during a remote chemistry exam, a federal judge has ruled. U.S. District Judge J. Philip Calabrese of the Northern District of Ohio granted summary judgment to student Aaron Ogletree in an Aug. 22 opinion. Ogletree's lawyer, Matthew Besser, told Cleveland.com that he thinks that the ruling is the first of its kind in the country. Ogletree had complied with the proctor's request to perform the room scan in February 2021, even though he objected beforehand because of tax documents in his bedroom. The scan, which lasted less than a minute, was recorded. Other students taking the test can also see the room scans. Pa. Supreme Court rolls back med-mal venue rules, allowing plaintiffs greater filing leeway - The Supreme Court of Pennsylvania's Civil Procedural Rules Committee has greenlit such rules allowing plaintiffs statewide greater leeway in where to file medical malpractice liability cases, a move cheered by personal injury attorneys and criticized by health care and business interests. The rules undo a change which went into effect in 2002, which stated that plaintiffs could only file medical malpractice lawsuits in the counties where they received their injuries. Now, with the new rules approved by the state Supreme Court, set to go into effect in 2023, plaintiffs will be able to sue medical defendants in counties where they do business or have established ties.
