WEEKLY WRAP-UP

Following the recent regulatory trends, NLRB general counsel seeks to limit employers' use of artificial intelligence in the workplace - On October 31, the General Counsel of the National Labor Relations Board released Memorandum GC 23-02 urging the Board to interpret existing Board law to adopt a new legal framework to find electronic monitoring and automated or algorithmic management practices illegal if such monitoring or management practices interfere with protected activities under Section 7 of the NRLB ("Act"). The Board's General Counsel stated in the Memorandum that "[c]lose, constant surveillance and management through electronic means threaten employees' basic ability to exercise their rights," and urged the Board to find that an employer violates the Act where the employer's electronic monitoring and management practices, when viewed as a whole, would tend to "interfere with or prevent a reasonable employee from engaging in activity protected by the Act." Given that position, it appears that the General Counsel believes that nearly all electronic monitoring and automated or algorithmic management practices violate the Act.
