Apple Smartwatch antitrust case survives, showing 'freedom of design' is not absolute

- It's a case that challenges the limits of the "freedom of design" usually enjoyed by companies accused of product design changes alleged to harm competition. Ordinarily, a design change is not the kind of conduct that runs afoul of the antitrust laws, but on March 21, U.S. Judge Jeffrey S. White from the Northern District of California denied Apple Inc.'s motion to dismiss an antitrust case brought against it by AliveCor Inc. The suit alleges that Apple unlawfully maintained its monopoly in the market for heart rate analysis apps by updating WatchOS, the Apple Watch operating system on which AliveCor's heart rate analysis app runs. The second amended complaint would have added two claims under the Family and Medical Leave Act to six Title VII claims for his client, Melissa Luna. Google's 'privileged' email labeling, said to prevent lawsuit disclosure, was 'eyebrow raising,' judge says

- Google's alleged effort to shield emails from lawsuit disclosure through labeling was "eyebrow raising" but probably not sanctionable, a federal judge said Friday. U.S. District Judge Amit Mehta of Washington, D.C., commented on Google's Communicate With Care email policy in response to a Department of Justice request for sanctions. Google is accused of directing its employees using email for business communications to copy an attorney, add a "privilege" label, and include a "generic" request for counsel's advice. Frequently, the copied attorneys remain silent, "underscoring that these communications are not genuine requests for legal advice but rather an effort to hide potential evidence," government lawyers had argued. Dead ringer

- Dorsey & Whitney filed a lawsuit in Texas Northern District Court on behalf of Jostens Inc., which partnered with the Chicago Cubs as the team's official jeweler and maker of its 14-karat 2016 World Championship rings, valued as high as \$250,000 each. The suit arises from Ronald A. Haarsma and Heritage Auctions' 2021 offering of a counterfeit version of Cubs player Ben Zobrist's World Series ring, the original of which was used to make sample rings in preparation for production. Jostens accuses the defendants of refusing to return the counterfeit Zobrist ring, even though Heritage has already acknowledged that the ring is counterfeit and stolen from a batch of seven sample rings. Counsel have not yet appeared for the defendants. The case is 3:22-cv-00796, *Jostens Inc v. Haarsma et al*
