**Discovery Fail** – In the age of emails, text messages, Snapchats and voice memos, it isn't entirely unheard of to send an attachment to someone you didn't mean to, or to accidentally CC a message to half the office. What is a bit more high-stakes, and rarer, however, is when an attorney makes such a mistake during discovery — that is, by mistakenly producing a client's privileged information to the other side. One of the most momentous recent examples is what happened during Infowars owner Alex Jones' trial in a courthouse in Austin, Texas. Mary Mack, CEO and chief legal technologist at Electronic Discovery Reference Model (EDRM), said the moment is likely "going to be a gift to e-discovery," precisely because it brings to light the importance of e-discovery best practices.

Smoker can sue tobacco company for consumer fraud, even though she didn't use its products, state supreme court says - A smoker can sue the R.J. Reynolds Tobacco Co. for misrepresenting the health hazards of cigarettes, even though she smoked brands made by other companies, a Nevada Supreme Court panel has ruled. In a July 28 opinion, the panel majority said Sandra Camacho could sue under the Nevada Deceptive Trade Practices Act because nothing in the law limits consumer fraud victims to product users. AI system can't be an inventor under US patent law, Federal Circuit rules - The U.S. Court of Appeals for the Federal Circuit has ruled that an artificial intelligence system can't get a patent for two of its new inventions — a food container and a light beacon. The Federal Circuit ruled Aug. 5 that only humans can get a patent. The court based its decision on the wording of the U.S. Patent Act, which defines "inventor" as "the individual or, if a joint invention, the individuals collectively who invented or discovered the subject matter of the invention." The lawsuit was filed by Karpf, Karpf & Cerutti on behalf of a former Honeywell safety coordinator who claims he experienced a 'sexual harassment double standard' while in the workplace in which women employees were permitted to engage in offensive and explicit behavior without consequence. Counsel have not yet appeared for the defendants. The case is 1:22-cv-01232, *Barone v. Idexcel, Inc. et al.* 

**Judge OKs protective order in Delco man's suit against hair product he purchased at CVS** - A federal judge has authorized the entry of a confidential protective order in litigation filed by a Delaware County man, who alleged he suffered permanent vitiligo from using the products he purchased at one of its local pharmacy stores. Timothy Moore and Jean Moore first filed suit in the Delaware County Court of Common Pleas on Jan. 20 versus Combe Incorporated of White Plains, N.Y. and CVS Health Corporation of Woonsocket, R.I.
