**Second Circuit grants Fund's audit request well beyond CBA coverage** - In a decision that bodes poorly for unionized employers, the U.S. Court of Appeals for the Second Circuit recently held that a union benefit fund was contractually entitled to conduct an audit whose scope far exceeded the bargaining unit for whom fund contributions were required. Health care officials testify that med-mal venue rules rescission may cause another liability crisis - A group of health care officials testified before a complement of Republican state congressional representatives on Monday that a recent Supreme Court of Pennsylvania committee decision to allow plaintiffs greater flexibility in where to file medical malpractice cases, may have the ability to create another medical liability crisis statewide. Providing testimony to the House Republican Policy Committee were Dr. Michael R. Ripchinski, Chief Physician Executive, Penn Medicine Lancaster General Health, for the Hospital and Healthsystem Association of Pennsylvania; Zachary Shamberg, President and CEO, Pennsylvania Healthcare Association; Dr. Wilson Jackson III, Jackson Siegelbaum Gastroenterology, for the Pennsylvania Medical Society; and Jonathan Greer, President, Insurance Federation of Pennsylvania. According to Shamberg, the return of the venue rule "will force long-term providers to settle lawsuits and will take money away from residents", while Jackson testified that the state Supreme Court committee's decision "will cause increased physician burnout and will cause specialty physicians to stop performing highrisk procedures." Greer offered that the decision means "significantly higher malpractice insurance premiums." #### Florist plaintiff who sued over bad reviews may have case dismissed for improper service

- A florist who brought a defamation suit in response to poor reviews of his business that were posted on Facebook and who was disallowed from serving the social media platform with a third-party subpoena as a part of his case may see his case dismissed due to lack of service. Blossoms & Blooms, Inc. (doing business as "Domenic Graziano Flowers & Gifts") and Domenic Graziano first filed suit in the U.S. District Court for the Eastern District of Pennsylvania on April 21 versus Jane Doe. "On or about Dec. 14, 2021, defendant left a false and defamatory comment on the Domenic Graziano Flowers business profile page on Facebook.com, defaming both Graziano Flowers and Graziano himself. After Graziano Flowers removed the defamatory comment from their Facebook.com profile page, on Dec. 15, 2021 Defendant left a second comment on Facebook.com citing the removal of the first comment and doubling-down on defendant's defamatory comments," the suit said.
