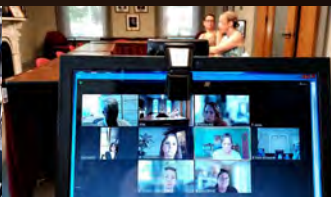

OSHA proposes more changes to recordkeeping rules - Employers across numerous industries may soon face additional recordkeeping and reporting obligations based on a new rule proposed by the Occupational Safety and Health Administration. In March 2022, OSHA proposed amendment of its injury and illness tracking rule, which requires certain employers to file illness and injury data with the agency each year. The tracking rule was first implemented in 2016, and required reporting of fatalities, hospitalizations, and other serious injuries for all covered employers with 250 or more employees, and for employers with 20-249 employees in certain “high hazard industries.” The rule required most covered employers to submit their Form 300A “Summary of Work-Related Injuries and Illnesses” annually. It also required certain employer establishments with 250 or more employees to submit their complete Form 300 Logs of Work-Related Injury and Illnesses, and their Form 301 Injury and Illness Incident reports annually. Finally, the rule called for creation of a public database of employer illness/injury data, including business names and illness/injury locations. Plaintiffs who suffered cardiac damage from licorice and sued Hershey's can continue their case - A federal judge has denied an attempt by Hershey to dismiss litigation from four plaintiffs who claimed they suffered permanent cardiac damage as a result of eating Hershey-brand black licorice. “Defendant Hershey is now, and at all times mentioned in this complaint was, in the business of producing and selling various food items, including certain black licorice products such as its Twizzlers and Good and Plenty brands. Black licorice contains the compound glycyrrhizin (also known as glycyrrhizic acid), which is the sweetening compound derived from licorice root,” the suit stated. “Glycyrrhizin can have very harmful effects on the body, such as causing potassium levels in the body to fall dramatically, and can create harmful imbalances in other minerals such as sodium. As a result, consumption of black licorice can cause people to experience abnormal heart rhythms, high blood pressure, edema (swelling), lethargy, and/or congestive heart failure.” Additionally, the suit said that while Hershey has faced litigation from other plaintiffs and/or their estates, who suffered permanent atrial fibrillation or death as a result of eating their black licorice product, it has not placed any warnings on that product. Not so sweet - Candy company Mars Inc. was hit with a consumer class action in California Northern District Court alleging that the company fails to warn customers about a harmful additive in its Skittles candies. The suit, backed by Bursor & Fisher, centers on the chemical titanium dioxide, or TiO₂, a coloring agent that has been banned as a food additive by the European Commission. Though TiO₂ has not been banned in the United States, the suit claims that Mars misled the public by continuing use of TiO₂ after suggesting in 2016 that it would remove the ingredient from its confectionary products. Counsel have not yet appeared for the defendant. The case is 4:22-cv-04145, *Thames v. Mars, Inc.*
