Third Circuit denies Ohio couple's appeal over fall at Erie casino, says sign was 'an obvious hazard' - The U.S. Court of Appeals for the Third Circuit has thrown out an appeal from an Ohio couple, who initially lost their case in a lower federal district court related to the wife's fall over a sign located on a casino's property. Third Circuit judges Cheryl Ann Krause, Peter J. Phipps and Julio M. Fuentes ruled on June 16 affirm the District Court's decision as to the motion for summary judgment and further denied the motion for certification.

'I regret any harm:' Short seller compensates target in rare move - A small Texas investor who caused shares of a real estate investment trust to plunge 39 percent in a day has agreed to pay the company restitution to settle a lawsuit against him, a rare development that could embolden other companies to pursue such claims. Quinton Mathews, who published his research on companies online under the pseudonym Rota Fortunae, will pay Farmland Partners Inc (FPI.N) "a multiple" of the profits on his short bet in 2018, according to the terms of the legal settlement announced late Sunday. His research had helped wipe as much as \$115 million off Farmland's market value.

**Justices Say Discipline Of Cheerleader Violated Free Speech** - The Supreme Court ruled in favor of a former high school cheerleader who argued that she could not be punished by her public school for posting a profanity-laced caption on Snapchat when she was off school grounds. The case involving a Pennsylvania teenager was closely watched to see how the court would handle the free speech rights of some 50 million public school children and the concerns of schools over off-campus and online speech that could amount to a disruption of the school's mission or rise to the level of bullying or threats. The 8-1 majority opinion was penned by Justice Stephen Breyer.
