MEMORANDUM OPINION AND ORDER ON DEFENDANT'S ORAL MOTION FOR RECONSIDERATION OF FIREARMS CONDITION

On September 30, 2022, the Defendant, Mikhail Slye, made his initial appearance before the Court on an Arrest Warrant and Criminal Complaint issued out of the United States District Court for the District of Columbia at its Docket No. 1:22-mj-00214. The Criminal Complaint alleges that Defendant committed several statutory offenses while he was present in and around the United States Capitol Building on January 6, 2021.¹ Specifically, the Criminal Complaint alleges that Defendant violated:

- 18 U.S.C. § 111, which makes it a crime to forcibly assault, resist, oppose, impede, intimidate, or interfere with any person designated in section 1114 of this title while engaged in or on account of the performance of official duties;
- 18 U.S.C. § 231 (a)(3), which makes it unlawful to commit or attempt to commit any act to obstruct, impede, or interfere with any fireman or law enforcement officer lawfully engaged in the lawful performance of his official duties incident to and during the commission of a civil disorder which in any way or degree obstructs, delays, or adversely affects commerce or the movement of any article or commodity in commerce or the conduct or performance of any federally protected function;
- 18 U.S.C. §§ 1752(a)(1), (2) & (4), which makes it a crime to (1) knowingly enter or remain in any restricted building or grounds without lawful authority to do so; and (2) knowingly, and with intent to impede or disrupt the orderly conduct of government business or official functions, engage in disorderly or disruptive conduct in, or within such proximity to, any restricted building or grounds when, or so that, such conduct, in fact, impedes or disrupts the orderly conduct of government business or official functions; (4) knowingly engages in any act of physical violence against any person or property in any restricted building or grounds; or attempts or conspires to do so; and
- 40 U.S.C. §§ 5104(e)(2)(D), (F) & (G), which makes it a crime to willfully and knowingly (D) utter loud, threatening, or abusive language, or engage in disorderly or disruptive conduct, at any place in the Grounds or in any of the Capitol Buildings with the intent

to impede, disrupt, or disturb the orderly conduct of a session of Congress or either House of Congress, or the orderly conduct in that building of a hearing before, or any deliberations of, a committee of Congress or either House of Congress; (F) engage in an act of physical violence in the Grounds or any of the Capitol Buildings; and (G) parade, demonstrate, or picket in any of the Capitol Buildings.

See ECF No. 1.

At the conclusion of Defendant's initial appearance, the Court ordered Defendant's release on a \$10,000.00 unsecured bond and subject to the conditions mandated by 18 U.S.C. § 3142(b) and certain discretionary conditions authorized by 18 U.S.C. § 3142(c), which the Court found necessary to reasonably assure the safety of other persons and the community and the appearance of the Defendant as required. The latter conditions included that "Defendant must ... not possess a firearm, destructive device, or other weapon."² ECF No. 11, ¶ 7(k). The Court included this condition over Defendant's objection but advised Defendant that the Court would consider his objection as a motion for reconsideration and revisit the issue after review of relevant case law.

Defendant's motion for reconsideration of the firearms restriction condition is based on the Supreme Court's recent decision in New York State Rifle & Pistol Ass'n, Inc. v. Bruen, 142 S. Ct. 2111 (2022) ("Bruen"). See also, United States v. Quiroz, 2022 WL 4352482 (W.D. Tex. Sept. 19, 2022) (holding that 18 U.S.C. § 922(n), criminalizing the receipt of a firearm by a person under indictment, is unconstitutional). Bruen arose out of a Second Amendment challenge to a New York law that required a person to demonstrate "proper cause" or "special need" to obtain a concealed carry license for a firearm. 142 S. Ct. at 2122. The Court found the law to be an unconstitutional restriction on the Second Amendment's protection of an "individual's right to carry a handgun for self-defense outside the home." Id. The Court held that "when the Second Amendment's plain text covers an individual's conduct, ... the government must demonstrate that the regulation is consistent with the Nation's historical tradition of firearm regulation." Id. at 2126. Here, there is no question that the Court's inclusion of condition $\P7(k)$ as a condition of Defendant's pretrial release is covered by the plain text of Second Amendment. That Amendment states: "A well regulated Militia, being necessary to the security of a free State, the right of the people to keep and bear arms, shall not be infringed." Condition \P 7(k) expressly prohibits the Defendant from possessing firearms while on pretrial release. Therefore, the dispositive question is whether this condition of pretrial release is consistent with the Nation's historical tradition of firearm regulation. The Court believes it is.

In *Bruen*, the Court acknowledged that determining whether a regulation comports with the Nation's historical tradition can be difficult in some cases and requires flexibility, stating that "the Constitution can, and must apply to circumstances beyond those the Founders specifically anticipated." *Id.* at 2132. As a result, the requisite historical inquiry "will often involve reasoning by analogy — a commonplace task for any lawyer or judge." *Id.*

² The Government did not request Defendant's detention, but expressly conditioned this position on the entry of conditions of release consistent with those imposed by the Court in prior cases involving similar charges arising out of the events of January 6, 2021. These conditions include $\P7(k)$. Pretrial Services also maintains that this condition is necessary to protect the safety of its officers who are responsible for supervising defendants on pretrial release and required to enter the homes and workplaces of such individuals in connection with their supervisory responsibilities.

Analogous regulations must be "relevantly similar." *Id.* Two metrics for this analysis are "how and why the regulations burden a law-abiding citizen's right to armed self-defense." *Id.* at 2133. The Court cautioned that this inquiry does not require a "historical twin," but rather a historical analogue. *Id.* ("[E]ven if a modern-day regulation is not a dead ringer for historical precursors, it still may be analogous to pass constitutional muster."). With respect to the New York law challenged in *Bruen*, the Court found that the historical record did not support "a tradition of broadly prohibiting the public carry of commonly used firearms for self-defense," or a tradition that would require "law-abiding citizens" to "demonstrate a special need for self-defense" to carry a firearm in public. *Id.* at 2138.

Here, historical reflection leads to a different outcome. At the outset, the Court notes that the Constitution has never guaranteed a criminal defendant's right to pretrial release. See United States v. Salerno, 481 U.S. 739, 754-55 (1987) ("Eighth Amendment does not grant absolute right to bail"). The precedent for denial of pretrial release to those accused of serious crimes dates to the early days of the Republic — indeed to English common law. The Judiciary Act of 1789 first established the right to bail "except where the punishment may be death," subject to judicial review based on "the nature and circumstances of the offence " Ch. 20, § 33, 1 Stat. 73, 91-92. Although the offenses considered "capital offenses" have changed materially over the centuries,³ the historical fact remains that pretrial detention and its attendant restrictions on constitutional rights have existed since the early days of the Republic. And, while denial of bail historically was most often based on the defendant's inability to post security, the fact remains that history recognized detention as a restriction that could be imposed upon a person who was accused, but not convicted of a crime. Inherent in this severe restriction of liberty is the temporary abridgement of numerous core constitutional rights including, but not limited to, freedom of speech (to the degree that such speech could undermine order and security in the prison), freedom of association, reasonable expectations of privacy, and, apropos to the instant case, the right to bear arms.⁴ It would be illogical to conclude that the Court has the authority to set conditions temporarily depriving an accused of all of the aforementioned constitutional protections by ordering his detention but lacks the authority to impose far less severe restrictions, such as ordering his release on bond with a firearms restriction.

The Bail Reform Act of 1984, 18 U.S.C. §§ 3141-3156, authorized judicial officers to release pretrial detainees subject to conditions determined to be reasonably necessary to assure the defendant's future appearances or the safety of individuals or the community. One such restriction commonly determined to be necessary to assure the safety of the community is the prohibition on the possession of firearms. Although the charges against the Defendant do not involve the use of firearms, many are crimes of violence. The condition prohibiting possession of firearms is recognized as necessary and appropriate in many cases for the protection of persons, including Pretrial Services Officers responsible for supervising pretrial releasees. This is true in this judicial district and likely all or most of the others. *See United States v. Perez-Garcia*, 2022 WL 4351967, at *4 (S.D. Cal. Sept. 18, 2022) ("To be sure, this [condition] is

³ For example, "'The Capitall Lawes of New-England,' dating from 1636, ... are the first written expression of capital offenses known to exist in this country. These laws make the following crimes capital offenses: idolatry, witchcraft, blasphemy, murder, assault in sudden anger, sodomy, buggery, adultery, statutory rape, rape, manstealing, perjury in a capital trial, and rebellion." *Furman v. Georgia*, 408 U.S. 238, 335 (1972).

regularly imposed in this and other judicial districts because it ensures the safety of Pretrial Services Officers who conduct home and work visits as part of their supervisory duties."); *United States v. Smedley*, 611 F. Supp. 2d 971, 964 (E.D. Miss. 2009) (imposing the restriction "is a precaution to safeguard pretrial services officers who will have contact with the defendant in their supervisory activities."). Where no condition or combination of conditions of release can reasonably assure the safety of persons or the community, federal law directs the pretrial detention of the defendant. 18 U.S.C. §3142(e)(1). Although regulations concerning pretrial release or detention have varied significantly during the 233 years that have elapsed since Judiciary Act of 1789, all have, in one form or another, authorized restrictions on the right of a criminal defendant to possess firearms.

Given the long-standing precedent for denial of pretrial release and its attendant denial of the right to possess firearms, the Court concludes that a condition of pretrial release prohibiting possession of firearms such as the one imposed here is consistent with the Nation's historical tradition of firearm regulation and, therefore, constitutional.

Accordingly, Defendant's motion for reconsideration of Condition \P 7(k) of his conditions of pretrial release is DENIED.



Firm has to face suit accusing it of violating patient confidentiality laws by touting med-mal win - A law firm will have to face a lawsuit claiming that it violated confidentiality laws when it disclosed mental health records about its lawyer client when touting a win in his medical-malpractice case, according to an Illinois appeals court. The Illinois Appellate Court's First Judicial District revived the lawsuit filed by a former corporate lawyer identified only as John Doe. Doe sued after Burke Wise issued a May 2015 press release, and one of its lawyers spoke with the Chicago Daily Law Bulletin about the jury award of more than \$4 million. The medical-malpractice suit stemmed from Doe's suicide attempt while in a hospital's psychiatric ward. Pa. Supreme Court says failure to request itemized verdict slip costs med-mal defendants \$3.8 million - The failure to request an itemized verdict slip has cost the defendants in a medical malpractice lawsuit \$3.8 million, per a ruling from the Supreme Court of Pennsylvania. The Court's Sept. 29 opinion reversed an earlier one from the Superior Court of Pennsylvania, which removed survival damages from the \$6.3 million jury verdict and called for a new trial on that survival claim — but now the case will be remanded to the Superior Court for further proceedings. "The jury in this medical malpractice case awarded the plaintiff Karen Cowher a lump sum amount of damages under the Survival Act, and did not itemize the amount of pain and suffering damages or other components of its aggregate award. Thereafter, the Superior Court granted the defendants Dr. Sobhan Kodali, St. Luke's University Health Network, and St. Luke's Cardiology Associates a new trial on survival damages, based on their claim the admission of plaintiff's expert opinion testimony on pain and suffering was erroneous," Supreme Court of Pennsylvania Justice Kevin M.
