

MEMORANDUM OPINION BY JUDGE LEAVITT

FILED: April 16,2021

Edward T. DiMattio, Jr. (Candidate) appeals a March 29, 2021, order of the Court of Common Pleas of Erie County (trial court) setting aside Candidate's nomination petition as a Republican candidate for the Office of Clerk of Records of Erie County and removing his name from the primary election ballot. Candidate argues that the trial court erred in holding that Section 1104(b) of the Public Official and Employee Ethics Act (Ethics Act), 65 Pa. C.S. §1104(b), precluded him from amending his statement of financial interests to correct a date, mistakenly written as "2021" instead of "2020." Upon review, this Court reverses.

Background

On March 9, 2021, Candidate filed several nomination petitions in support of his candidacy for the Erie County Office of Clerk of Records. Appended thereto was Candidate's statement of financial interests, which identified the reporting year as "2021." Certified Record (C.R.), Item No.7, Exhibit A. Candidate did not sign the financial statement. The nomination petition filing deadline was March 9, 2021.

On March 16, 2021, Candidate filed an amended financial statement, which identified the reporting year as "2020" and was signed and dated. Both financial statements identified Candidate's "occupation or profession" as "project manager." C.R., Item No.9, Exhibit 1. Candidate had no "real estate interests" and received no "direct or indirect sources of income" or "gifts." *Id*.

Later that same day, Erin Morgan and Helen Wisemiller (collectively, Objectors) filed a petition to set aside Candidate's nomination petition under Section 977 of the Pennsylvania Election Code (Election Code). Objectors asserted that Candidate had failed to timely file a financial statement for "the preceding year," which Objectors described as a fatal defect under Section 1104(b)(3) of the Ethics Act, 65 Pa. C.S. §1104(b)(3).

On March 22, 2021, Candidate filed, *inter alia*, an answer and new matter. Candidate averred that the year "2021" in box number 7 was an inadvertent error; the financial statement correctly described his financial interest for 2020; and he had filed a corrected financial statement with "2020" entered in box number 7.

The trial court conducted a hearing on March 24, 2021. Objectors presented Candidate's testimony as on cross-examination and submitted into evidence a financial statement that Candidate filed in March 2017, in connection with his candidacy in the 2017 primary election. The 2017 financial statement stated that the information was disclosed for the year "2017." Candidate testified that the 2017 financial statement covered 2017, rather than the preceding year. However, no challenge was raised to the 2017 nomination petition. Notes of Testimony, 3/24/2021, at 30 (NT. __). By contrast, Candidate's financial statement filed on March 9, 2021, was for 2020; the year "2021" entered at box number 7 was an oversight. N.T. 31. Candidate testified as follows:

[Objectors' Counsel:] Isn't it true ... that when you completed this form on March 9th, 2021 [,] you thought that you had completed it correctly?

[Candidate:] Yes.

[Objectors' Counsel:] And you thought you completed it correctly, at least in part because that's the same way you completed the form in 2017 and no one objected?

[Candidate:] It's hard for me to say from 2017 to 2021. But in 2021 — or when I submitted this form, I thought that I submitted it correctly.

[Objectors' Counsel:] And that's due in part because you had done it the same way in 2017 and no one said that you did it wrong?

[Candidate:] I did not use 2017 as a template. Every year that I was in elective office, which was fi[v]e, I filled out five of these forms.

N.T.34-35.

Candidate further testified that because he has been unemployed since 2019, he considers "project manager" to be his profession. N.T. 33. He has earned income, but it was not reportable for either the year of 2020 or 2021. Candidate acknowledged that he did not sign the financial statement filed on March 9, 2021. He testified that he had signed numerous forms on that day and simply missed the financial statement.

Trial Court Decision

On March 29, 2021, the trial court granted Objectors' petition to set aside and ordered Candidate's name to be removed from the primary election ballot. The trial court found that Candidate "made an honest mistake" in filling out the financial statement on March 9,

2021, and "did nothing ethically or morally wrong[.]" Trial Court op. at 7. Nevertheless, the trial court concluded that the mistake was a fatal defect under Section 1104(b) of the Ethics Act. The trial court further opined that the amended financial statement filed on March 16, 2021, was untimely because it was filed one week after the filing deadline of the nomination petition.

Candidate appealed to this Court.²

Appeal

On appeal, Candidate presents two issues for review, which this Court combines into one for clarity. Candidate argues that the trial court erred by concluding that the fatal-defect clause of Section 1104(b) of the Ethics Act precluded him from amending the financial statement. The Supreme Court has held that all defects related to the content of disclosures on a timely-filed financial statement can be amended where, as here, errors were made inadvertently and in good faith without intent to deceive. Candidate Brief at 10 (citing *In re Paulmier*, 937 A.2d 364 (Pa. 2007)). Where the financial statement is not filed at all, or filed in the wrong office, then it cannot be amended.

Objectors counter that Section 1104(b)(2) of the Ethics Act requires that candidates for county level office file a financial statement "for the preceding calendar year." 65 Pa. C.S. §1104(b)(2). Failure to do so constitutes a "fatal defect" to the petition to appear on the ballot. 65 Pa. C.S. §1104(b)(3). Here, Candidate filed the original financial statement for 2021, rather than 2020, and without a signature. These defects, Objectors contend, "are the functional equivalent of [Candidate] not filing a [s]tatement of [f]inancial [i]nterests at all." Objectors' Brief at 10. In support, they cite *In re Guzzardi*, 99 A.3d 381 (Pa. 2014), where our Supreme Court held that Section 1104(b) is unambiguous and should be strictly enforced.

Section 1104(b) of the Ethics Act provides in pertinent part follows:

(b) Candidate.—

* * *

- (2) Any candidate for county-level or local office shall file a statement of financial interests for the preceding calendar year with the governing authority of the political subdivision in which he is a candidate on or before the last day for filing a petition to appear on the ballot for election. A copy of the statement of financial interests shall also be appended to such petition.
- (3) No petition to appear on the ballot for election shall be accepted by the respective State or local election officials unless the petition has appended thereto a statement of financial interests as set forth in paragraphs (1) and (2). Failure to file the statement in

accordance with the provisions of this chapter shall, in addition to any other penalties provided, be a fatal defect to a petition to appear on the ballot.

65 Pa. C.S. §1104(b) (emphasis added). Section 1104(b) has been construed in several appellate decisions.

In *Paulmier*, 937 A.2d 364, our Supreme Court held that a content error in a timely filed financial statement can be amended. In that case, the candidate's statement of financial interests did not disclose the addresses of certain real properties and the names of the tenants who had paid the candidate in the previous year. The trial court ordered the candidate's name to be removed from the ballot, and this Court affirmed. On further appeal, the Supreme Court reversed. It explained that

the fatality rule announced in Section 1104 of the Ethics Act was intended by the Legislature to bar only those candidates from the ballot who fail to file statements of financial interests or who file them in an untimely manner. Section 1104 does not bar any candidate from the ballot if he or she files in a timely manner, even if there are defects on the face of the form, so long as that candidate subsequently amends the form to correct the defect and comes into compliance with the Act in a timely manner. In other words, all defects related to the content of disclosures on a timely filed statement of financial interest are subject to timely amendment.

Paulmier, 937 A.2d at 371 (emphasis added). In sum, defects on the face of the form can be corrected in a timely manner.

Consistent with *Paulmier*, this Court held in *In re Wissinger*, 18 A.3d 445 (Pa. Cmwlth. 2011), that the candidate could amend a timely filed statement of financial interests by adding her signature and the office she sought to be a candidate. We rejected the objectors' argument that the candidate's failure to sign the financial statement rendered it legally ineffective and equated to a lack of filing. Rather, "these defects are apparent on the face of the financial statement and are amendable" under Section 11 04(b) of the Ethics Act. *Wissinger*, 18 A.3d at 448.

In *Guzzardi*, 99 A.3d 381, objectors filed a petition to strike the candidate's name from the ballot because he did not timely file his statement of financial interests with the Pennsylvania State Ethics Commission (Ethics Commission) but, rather, with the Secretary of State. "Although an original statement of financial interests was appended to [the nomination] petition, [the candidate] failed to make the mandatory tender to the Ethics Commission prior to the statutory deadline." *Id.* at 382. Employing equitable principles, this Court denied the petition to strike based on the candidate's explanations for his late submission. In reversing, the Supreme Court stated that courts are not free to disregard the explicit statutory command that the failure of a candidate for statewide public office to file a timely statement of financial interests with the Ethics Commission constitutes a fatal defect to a petition to appear on the ballot. It explained as follows:

the judiciary should act with restraint, in the election arena, subordinate to express statutory directives. Subject to constitutional limitations, the Pennsylvania General

Assembly may require such practices and procedures as it may deem necessary to the orderly, fair, and efficient administration of public elections in Pennsylvania. At least where the Legislature has attached specific consequences to particular actions or omissions, Pennsylvania courts may not mitigate the legislatively prescribed outcome through recourse to equity.

Id. at 386 (emphasis added). Notably, the Supreme Court did not overrule *Paulmier*, but, rather, cited it with approval. The Court concludes that *Guzzardi* is limited to the circumstance where a statement of financial interest is not timely filed or filed in the wrong office on the filing deadline.

In the case *sub judice*, Candidate timely filed the financial statement on March 9, 2021. The trial court found that Candidate made an "honest mistake" and "did nothing ethically or morally wrong." Trial Court op. at 7. The trial court found the information disclosed in the original financial statement was in fact for 2020, even though the form identified 2021. Stated otherwise, the defect was a content error that is obvious from the face of the document and was not made in bad faith.

Objectors assert that the amended statement of financial interests filed on March 16, 2021, was untimely because it was filed one week after the filing deadline of the nomination petition. Amendments to timely filed statements are not subject to the deadline for filing of the nomination petition. For example, the trial court in *Wissinger*, 18 A.3d 445, granted the candidate leave to amend her financial statement on March 18, 2011, 11 days after the filing deadline of the nomination petition.

This Court's decision in *In re Lee* (Pa. Cmwlth., No. 413 C.D. 2015, filed April 17, 2015) (unreported)³ is instructive here. There, the objector filed a petition to strike the candidate's nomination petition alleging numerous fatal defects, including the fact that the candidate's statement of financial interests identified the calendar year as 2015 rather than 2014. The candidate then filed a new statement identifying the calendar year as 2014. At a hearing, the candidate testified that he was rushed when filling out the original financial statement and did not realize that he wrote down the year 2015 until he received the objection. The trial court discredited the candidate's testimony and found that the candidate acted in bad faith. *Lee*, slip op. at 7. The trial court directed the candidate's name to be removed from the ballot.

The candidate appealed. In affirming the trial court, this Court first noted that content defects on a timely filed statement of financial interests are amendable. However, Section 1105(a) of the Ethics Act⁴ imposes a "good faith" filing obligation on the part of a candidate, even though he may have an opportunity to amend the financial statement. *Lee*, slip op. at 10 (citing *Paulmier*, 937 A.2d at 371). Because the trial court found that the candidate acted in bad faith when filing the original financial statement, we held that the trial court did not err in not permitting the candidate to amend it. *Lee*, slip op. at 11.

By contrast, here, Candidate testified that he wrote "2021" in the original financial statement inadvertently with no intent to deceive the voters. Prior to any objection to the nomination petitions, Candidate filed an amended financial statement with the correct year "2020." The disclosures on both financial statements appear identical, except for the year. The trial court found that Candidate made an honest mistake when filing the nomination petitions. Because Candidate timely filed the financial statement and did so in good faith, the fatal-defect rule in Section 1104(b)(3) of the Ethics Act does not prevent Candidate from correcting the errors on the face of the financial statement. *Paulmier*, 937 A.2d at 371.

Accordingly, the order of the trial court is reversed.

ORDER

AND NOW, the 16th day of 2021, the Order of the Court of Common Pleas of Erie County, dated March 29, 2021, entered in the above-captioned matter, is hereby REVERSED. The Erie County Board of Elections is directed to place the name of Edward T. DiMattio, Jr. on the May 18, 2021, Municipal Primary Election ballot as a Candidate for the Republican nomination for the Office of Clerk of Records of Erie County. The Chief Clerk is directed to send a copy of this Order to the Erie County Board of Elections.


