

**No judgement here** - Incidents of witness coaching during remote court proceedings have, thankfully, not become an epidemic during the pandemic as some feared. But, so far, when they have occurred, ethics authorities have shown a fair amount of mercy to the offending lawyers, perhaps in recognition of the fact that virtual litigation is still pretty weird for everyone involved. It can easily happen but at least for now, disciplinary authorities appear somewhat understanding of these ethical lapses given the unprecedented circumstances. However, that level of leniency is not something anyone should bet on continuing, particularly as remote proceedings become increasingly entrenched as part of normal day-to-day court operations and the expectations around what is and is not allowed become clearer.
